DESCRIPTION OF ACTIVITY

CCPMI points out the necessity of uniting the public to counterbalance political speculations on existing conflicts, contributing to the formation of public need for peace and restoration of goodneighborly relations in the South Caucasus, promotion of settling the "frozen" conflicts on the basis of human rights and freedoms. We try to involve the largest possible number of citizens in order to prevent or minimize hostility between peoples and political exploitation of it; we try to consolidate the social demand for good neighborly relations and to form social demand for guaranteed peace.

The organization recognizes the importance of maintaining friendly relationship; close contacts, constructive dialogue as well as peace-making initiatives with the similar structures operating in the neighboring countries. Our priorities are citizens' active involvement and peacemaking aimed to promotion of civic dialogue and restoration of neighborly relations. Within these two formats we try to move gradually from talks about territorial claims and confrontation to respect for human rights and basic freedoms. CCPMI conducts public awareness activities, organized rallies, discussions, meetings, conferences and performances.

Current programs of CCPMI:

"South Caucasus Integration: Alternative Start" (started at 2005) is a civic initiative aimed to revision of existing problems in civic dialogue and searching the new alternative modes for promotion the peace and conflict resolution in South Caucasus.

The tragic events in August 2008 in Georgia, the new wave of Russian expansion in region at general, provoked the return of "cold war" and at the same time "soviet internationalism" rhetoric. Even in Georgia the public opinion is formulated around the idea of geopolitical struggle between Russia and West (NATO), and in all societies of South Caucasus countries become more and more disillusioned with the West (European) principles of coexistence, civic dialogue or any cross border civic initiatives. Inactivity and lying-in-wait are cultivated now in public opinion, which trust only to pragmatism of being small change in geopolitical games.

We think that in current situation there is the need of "fresh air" - new ideas, new formats, and new modes of civic activity aimed to reconciliation, good neighborhood in South Caucasus founded on universal values of human rights and tolerance. Number of meetings and joint projects are already implemented by members of this initiative, it is planed to elaborate the starategy for permanent activity of the South Caucasus Citizens Congress, to carry out public awarness campaign regarding the goals of the Congress, to strengthen the collaboration between partners, etc.

"Human Rights Defender School" is the program of CCPMI started in December 2007. The short study course of human rights and civil peace-making is elaborated for schoolchildren. The first classes were leaded by our partners from Azerbaijan – human rights activists, lawers and journalists. The longterm goal of this activity is creating of human rights defenders network in Armenian secondary schools and developing the experience of engagement the guest teachers from neighbour countries Azerbaijan and Georgia.

"Step into dialog: Armenia-Azerbaijan-Turkey" the implementation of this program within the context of Armenia-Azerbaijan-Turkey is based on the result of our public discussions and work experience in the stereotypes overcoming sphere. Undoubtedly the political problems are not the same in Armenian-Azeri and Armenian-Turkish relations, but there is not any doubt that the complex of enemy stereotypes is based on the same ideology, namely, the historical confrontation between Armenians and Turkish world.

Current projects of this program are aimed to open for Armenian society a part of present-day Turkey and Azerbaijan by screening the films from these countries. The selected films will not be "made special for Armenian audience" but they will apply to social and human rights problems which are very topical in Armenia too. So the main idea of this project is to encourage the interest to neighbor countries by means of acquaintance with new generation in Turkey and Azerbaijan through their works; by means of acquaintance with the personages of these films - simple peoples, their views and their troubles. We suppose that in current contexts this festival will be able to enlarge the communication field between our societies, and will be able to give an opportunity for opening the new way for dialogue focused in common to all mankind issues.
